Charges from 1st April 2006

SECTION A

For all craft except those charged under B, C, D, E and F

<u>Part 1</u> - Harbour dues payable by all vessels moored/launched within the Estuary and registered at the Harbour Office	<u>Per Annum</u>
Up to and including 4.5 metres in length	£21.55
Over 4.5 metres	£21.55 plus £16.35 per metre over 4.5m.

Band 1

Daily charge (Maximum 3 days) Visitor £4.43 per day

Band 2

Sailboards, canoes, sailings dinghies and any vessel without any engine up to 4.5mtrs in length £11.07 per annum

Band 3

Any vessel with an engine up to 4.5mtrs in length £21.28 per annum

Band 4

Any vessel over 4.5mtrs £51.06 per annum

Part 2 - For yachts, motor cruisers and other visiting vessels

ENTERING the harbour

Daily dues only (per day or part thereof) £0.77 per metre

Daily mooring and dues (per day or part thereof) £1.53 per metre

Weekly dues only £4.21 per metre

Weekly mooring and dues £8.42 per metre

N.B. Weekly rates are compounded at five and a half times the daily rate

All charges apply to the overall length of the vessel (excluding bowsprit)

The charges for visiting multi-hulled vessels will be increased by 100% if such a vessel requires the single occupancy of a visitors berth

Of and over 100 tonnes	£0.40 per tonne N.R.T.

SECTION D

For houseboats, yachts and motor cruisers used as houseboats	
Up to and including 4.5 metres in length per annum	£37.66
Over 4.5 metres in length per annum	£37.66 plus £28.56 per metre over 4.5

SECTION E

For Tugs which shall enter or use the harbour	
Per day or part thereof	£17.41

SECTION F

For laying up merchant vessels -	
Laying up on foreshore each vessel per year or part	£11.21 per metre
Laying up afloat each vessel per month or part thereof	£0.69 per tonne N.R.T.

SECTION G

On goods shipped, unshipped or transhipped within the harbour	
Per tonne	£1.03

Provided that no rates or charges are payable on shellfish
