(AMENDMENT) ORDER 2004

SOUTH HAMS DISTRICT COUNCIL ("the Council") in exercise of their powers under sections 35 (1) (3) and (3A) and Paragraph 27 of the Ninth Schedule to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, with the consent of Devon County Council in accordance with Section 39(3) of the Act, and after consulting the Chief Officer of Police in accordance with Paragraph 20 of the Ninth Schedule to the Act, hereby make the following Order:-

- **AMENDMENT (number 2) ORDER 2004**

1. Commencement and Citation

This Order shall come into operation on the 25th March 2004 and may be cited as the District of South Hams (Off-Street Parking Places)(Amendment) Order 2004.

2. Interpretation

Interpretation of this Order shall be as provided for in Article 2 of the District of South Hams (Off-Street Parking Places) Order 1999 ("the Principal Order").

3. Amendment

The Principal Order shall be amended by:-

- (a) The deletion of the Schedule thereto, and its substitution by the Schedule to this Order;
- (b) The extension of the parking restrictions in relation to the following Car Parks:
 - (i) Poundwell Street, Modbury
 - (ii) Victoria Street Car Park, Totnes
- (iii) In all fee paying car parks, parking on Sundays will no longer be free of charge
- (c) To include parking restrictions for the following Car Parks:
 - (i) Dartmouth Leisure Centre
 - (ii) Erme Court, Ivybridge
 - (iii) Creek Trailer Park (opposite boat park), Salcombe
- (d) To introduce a reserved boat parking charge at Aveton Gifford Car and Boat Park in the sum of £100.00.
- (e) To introduce a charge for parking overnight (6pm to 8am) at Victoria Street Car Park, Totnes in the sum of £1.20 per car.
- (f) Any Leisure Centre Car Park Pass will entitle Leisure Centre Members to park in the relevant car parks for no more than four hours per day.

(g) The amendment of Clause 6 ("the amount of standard charge at Parking Places") as follows:

(i) All reference to £60.00 to be changed to £70.00 (the Standard Charge); and

(ii) All references to £30.00 to be changed to £40.00 (the reduced rate of Standard Charge where payment is made within seven days)

(h) The amendment of "Part III Exemption" to "Part III 1 Hour Free Parking" and Clause 23(l) namely:-

"The following Vehicles left in a Parking Bay reserved for the use of vehicles by disabled persons shall be entitled to an additional hour of free parking on top of the payment of the Scale Charge specified in Clauses 4 and 5".

The remainder of that Clause as from sub clause (a) shall remain as per the wording in the Principal Order.

NOTICE is hereby given that the South Hams District Council has made the above named Order in exercise of its powers under Section 35(1)(3) and (6) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers.

The Order came into operation on the 9th April 2004.

A Notice setting out the Council's proposal was published in this newspaper on 23rd January 2004.

In accordance with that Notice the Order provides for the inclusion of the alteration to the charges for the car parks at Cookworthy Road and Cattle Market Car Park, Kingsbridge, Pavilion Car Park, Totnes and Bigbury on Sea Car Park.

The Order may be examined at Follaton House, Plymouth Road, Totnes on Mondays to Fridays 9.00am to 1.00pm and 2.00pm to 4.30pm. Any person who wishes to question the validity of the Order or of any of its provisions on the ground that it was not within the powers conferred by the Act, or that a requirement of the Act or any relevant regulations made thereunder have not been complied with, may within 28 days from the date of publication of this Notice apply to the High Court for that purpose.
